Terms & Conditions



Fundraising

1. You agree to organise fundraising activities as an independent supporter of Nelson Tasman Hospice (registered charity no. CC24279). You should therefore refer to raising money in support of Nelson Tasman Hospice, rather than on Nelson Tasman Hospice's behalf.
2. In the course of any fundraising activities in support of Nelson Tasman Hospice, please refer to the charity as Nelson Tasman Hospice.
3. You agree that you shall comply with any instructions or guidance provided by Nelson Tasman Hospice relating to your fundraising activity, but it is your responsibility to organise all aspects of any fundraising activity undertaken by you, unless expressly agreed otherwise by an authorised member of the Nelson Tasman Hospice team.
4. Unless expressly agreed otherwise by an authorised member of the Nelson Tasman Hospice Trust you will be responsible for any costs, taxes or expenses incurred or arising in connection with your fundraising activity.
5. You agree to use Nelson Tasman Hospice branded assets and materials as provided. Please email fundraising@nelsontasmanhospice.org.nz for any questions or requests regarding branded assets or materials.

Use of personal data and consent

1. By providing your information when you sign up to fundraise for Nelson Tasman Hospice you agree that Nelson Tasman Hospice can use the details to discuss your fundraising activity and follow up on your progress.
2. Your personal information may also be used for the purposes of sending communications to you where you have confirmed that you would like to receive further information about the charity's work when signing up to fundraise for Nelson Tasman Hospice.
3. All personal data held by us will be handled in accordance with applicable privacy laws and Nelson Tasman Hospice's privacy statement, which can be found at <https://www.nelsonhospice.org.nz/privacy/>

Content

1. If you share any photos or videos taken during your fundraising activity with the team at Nelson Tasman Hospice, you agree that these may be used by Nelson

Tasman Hospice for promotional purposes. By sharing these, you are also confirming that anyone featuring in the photo or video is aged 16 or over, and that they have consented to their image being used in this way.

Liability

1. You accept that any risks arising out of your fundraising activity are your responsibility, including liability for any injury or loss which may occur to you, your helpers or guests. You will therefore take all reasonable precautions to protect the health and safety of all those participating in, involved with, or attending your activity.
2. You will comply with any applicable laws and regulations relating to your fundraising activity, including obtaining any necessary licenses, consents or permissions e.g. if you are holding a raffle or lottery, or are proposing to sell alcohol.
3. You acknowledge and accept that Nelson Tasman Hospice's insurance policy will not cover your fundraising activities.
4. You will not do anything that threatens Nelson Tasman Hospice's reputation or name. If you do, Nelson Tasman Hospice Trust has the right to ask you to stop your fundraising activity immediately.
